2 *Requirements* - Please, submit the following:

- application completed in full and signed,
- copies of all certificates and diplomas,
- certified English translation of all documents issued not in English (Certified English translation is a translation, prepared by a certified translation agency, with an Affidavit of Translator and a company seal). We will not accept any translations, prepared outside the United States.
- Money Order or check made out to A&M Logos International, Inc. must be enclosed
